- Measure Dropping
- DOE is working on EA and QCI cost



# Measure Dropping – How to

- Organize measures in audit by high to low SIR
- Drop from bottom up
- CANNOT drop a major measure
  - Air sealing
  - Duct sealing
  - Attic insulation
  - Wall insulation
  - Floor insulation

### Vehicles and Equipment/State Contract Pricing

Agencies Procurement Policy and Procedures (consider adding language like):

- Vehicle & Equipment procurement requests:
  - Per <u>2 CFR 200.318(e)</u>, "To foster greater economy and efficiency, and in accordance with efforts to promote cost-effective use of shared services across the Federal Government, the non-Federal entity [Subgrantee] is encouraged to enter into state and local intergovernmental agreements or inter-entity agreements where appropriate for procurement or use of common or shared goods and services...."

Subgrantee Vehicle/Equipment procurement requests can be expedited when Subgrantees include an option to use Kentucky pre-negotiated procurement agreements in their respective policies/procedures and typically provides a better price/value than the Subgrantee can achieve on their own.

DBCAA may utilize state contract pricing agreements for any item or service available through a current state bid.





### Vehicles and Equipment

### Vehicle Condition Requirements

- DOE requires us to follow 2 CFR 200.313(d)(4): Adequate maintenance procedures must be developed to keep the property in good condition.
  - Vehicles must be in "good" condition
  - Language is in the DOE State Plan
  - DOE will issue a finding if less than "good" condition

Equipment purchases can be made at any time unless total costs are over \$5,000.



### Vehicles and Equipment



All vehicles obtained with weatherization contract funds will remain the property of KHC and shall be used exclusively for weatherization purposes. Personal use or use of vehicles for purposes other than weatherization program purposes is strictly prohibited. Vehicles may not be used for commuting purposes to and from an employee's home.

- Mandatory
- Trainings offered starting in September
- One week course





# Weatherization Ready

- Deferral list
- WPN 23-4 allows the following:
  - Weatherization Ready money allowed to rollover
  - Does not have to be completed this program year, can be in-progress
  - Must be finished with WX completion by June 30, 2025
- Must be completed within a reasonable time 120 days
- Wx Ready has an ACPU of \$10,000
- Reminder- DOE Weatherization Ready can be combined with DOE Formula and DOE BIL projects
- Final invoice and final photos for draw submission
- Create separate invoice in Hancock for Wx Ready





# Weatherization Ready

- DOE Wx Ready jobs need to become a DOE completion. At least \$1 or measure to DOE Formula or DOE BIL.
- Only DOE Wx Ready funding available
  - Mods allowed if LIHEAP only job
- Important that the money is being spent, send scenarios to KHC to review if any are in question

Kentucky

- No major structure repairs
- Funding is not to replace the need for a contractor.
- Submit success stories
- Updated form on website and partner portal

# **TA Monitoring Findings**

- Re-work on completed units cannot be charged to DOE.
- No material cost in program support.
- Where do you add your labor cost?

### **KHC PN Summaries**

### KHC PN 01-2024- Contractor Training Requirements

Any HVAC, electrical, or plumbing contractors, who are onboarded for weatherization to perform tasks only included in their professional licensure, will not be required to attend weatherization training. They will only be allowed to perform duties that their professional training allows them to perform. General weatherization contractor tasks, such as insulation installation, air sealing, duct sealing, Ashrae fan installation, are not part of those professional duties and would fall subject to the training requirements for general weatherization contractors.

### KHC PN 08-2023 SHPO Update

Manufactured housing is excluded from a SHPO review. Units in which all the weatherization measures meet the exemptions listed in the PA may proceed without a SHPO review. If any measure is identified that does not meet the exemptions listed in the PA, a SHPO review under the current process is required.



### **KHC PN Summaries**

### KHC PN 07-2023 H&S Limits & Window/Appliance Replacement

**H&S:** increased the cap of H&S from \$3000 to \$4000

**Window/Appliance Replacement:** KHC will require any window replacements to be energy-star rated in stick-built homes and a minimum U-value of .5 in mobile homes. All other appliance replacements should be energy-star rated, and all replacements (windows and appliances) should be documented in client files

### KHC PN 06-2023 ANSI/BPI 1200

Kentucky will start using the ANSI/BPI 1200 standard for CO action levels starting August 14, 2023
